Dear Friends,

Thank you to all who provided such generous support during this last year. It was particularly heartwarming as we coped with the impact of the COVID-19 pandemic and made the changes necessary to continue providing critical services. You helped build a community in which children and families are supported to live their full potential.

2019-2020 saw us add pediatric occupational and physical therapy to our services and a satellite classroom to our Relief Nursery in Monroe, while continuing to provide all our other programs. The need for the assistance offered by our six programs continues as families face challenges from the impact of the pandemic. Multigenerational mental health and addiction; the impact of mental illness on families and children; economic pressures from high housing costs, and marginalization of some families continue. The stress caused by these factors affects children particularly hard. Without additional support they can struggle in their development.

In addition to working with individual children and families to address their specific needs, we also work to positively impact the structural systems that discriminate against people of color, those with disabilities, and other marginalized groups. Our vision for a community working collaboratively to ensure all children and families have access to early education, as well as behavioral and mental health services to improve their well-being, requires us to do this work as well. I invite you all to join us in this important work. Please raise your voices with us.

As we work with children and their families, we see them grow, become more resilient, and participate more fully. We could not do this life changing work without you. Community support is key to our success.

One Kid's Journey

When Jeremiah was 3 years old his 8-month old sister was scared of him. Most adults were, too.

At the age of 3 he had a vocabulary that literally consisted only of four letter words – it's all that he had been exposed to. His home was full of chaos, stress and



turmoil. His future was likely to be a pathway of suspension, expulsion, foster care or worse.

But his Relief Nursery teacher had faith. She believed Jeremiah was trying to communicate. With compassion, understanding and patience, she was able to create positivity and a trusting environment in Jeremiah's home. Through a combination of home and class care, she built trust with this family; then we saw rapid positive changes in Jeremiah.

He was able to let his guard down. He learned how to channel his anger. He learned how to use the right words and to express his needs in a way that adults and his peers can relate to and understand.

When the time came last year, Jeremiah was able to enter kindergarten with his tool belt full of positive resources.

Most rewarding of all is to see his little sister smile when she sees him.

Jeremiah learned self-regulation skills, how to take deep breaths, and how to use kind words to get his needs met.


We hosted this weekly group curriculum for highly stressed parents of children ages 0 to 8.

Monroe Relief Nursery

In 2019–20, the dream of bringing much needed early childhood education and parenting support services to the Monroe community through a Satellite Relief Nursery Classroom on the grounds of the Monroe Grade School became reality. Through generous foundation grants and local community support, we were able to complete the classroom renovation, build a playground, purchase furnishings and supplies, hire staff and achieve Child Care Licensing.

With the onset of the pandemic, classroom operation was temporarily halted in March. Our staff continued to provide early education, parenting support, respite care and resources to the families in south Benton County and limited onsite services started back up in July 2020.

The initial 3-year project community donation goal was \$120,000. As of June 30th, 2020, we raised 75% of the community funds needed. Thank you to all the donors, businesses, and organizations who are helping make the Monroe Relief Nursery a reality.





Manuel was terrified of going to class. Before we opened, he came to visit. We showed him pictures and did all we could to prepare him.

Educating Future Therapists & Early Childhood Professionals

For many years, Old Mill Center has been a coveted option for Master's Students studying child and family or family and marriage counseling. Through the 2019-20 year, the Outpatient Department hosted 3 interns from George Fox University who collectively gave over 1200 hours of work to the program. Our focus on children's therapy combined with our trauma-informed environment, extensive training opportunities and real-world practice, makes OMC very attractive to students who need to log a full school year as interns.

Each intern may take on as many as 25 clients. While interns are gaining experience, we are able to expand our capacity.

It is a mutually beneficial program. Over the course of a year, an intern may take on as many as 25 clients, providing supervised therapy sessions and conducting group sessions. While interns are gaining real-world knowledge and experience, we are able to expand our capacity to help more children and families and bill for their services. The result is a break-even proposition. We absorb the cost of their supervising and training time, while they perform as active team members.

In addition to the cost-benefit

ratio, Old Mill Center benefits from its long standing collaborative relationships with higher education institutions in the Pacific Northwest. Once their internships and degrees are completed, new therapists often join our team as staff. 50% of our Counseling staff are former OMC interns.

Internships are active in several of our other programs including Relief Nursery, ITS, Occupational and Physical Therapy and Preschool. Over 2300 hours of intern work was logged in 2019-2020, saving as much as \$48,000 in payroll, while helping to educate future professionals.

Volunteers Make the Difference

There are many ways to support the work we do. Most precious may be the great work done by so many volunteers. For instance, Tim & Hilma Kaye. From sewing required blackout drapes for security, or weighted blankets for the comfort of those in therapy to building a music wall in the playground, painting, and grounds work, Tim and Hilma have devoted nearly 100 hours of service to the Center this year. We see them often and in so many different capacities! They are two shining examples of how volunteers make things happen at Old Mill Center. Thanks for everything you do, Hilma and Tim!

Occupational and Physical Therapy Back at Old Mill Center

When most people think about Old Mill Center, our preschool, early intervention, mental health and parent support services come to mind. But we also support children's physical wellbeing with a range of Occupational & Physical Therapy services.

Our therapists help kids (ages 0–18) build gross motor and sensory skills and increase strength, flexibility, coordination and balance. The goal is to help each child be as independent as possible in all of their daily activities.

These are just a few of the conditions our therapists can help with:

- Cerebral palsy
- Developmental delay
- Down syndrome
- Eating & swallowing challenges
- Fetal alcohol syndrome



- Orthopedic injuries
- Postural imbalance
- Seizures
- Sensory processing disorder
- Spina bifida
- Strokes

Did You Know...

Telemental Health – "Telehealth" for short – lets us bring therapy, skills training and other services right into our families' homes. It is used by all of our programs to continue serving our kids and families. It allows children to heal in their own homes.

Financial Overview

The financial year concluded with a small surplus of \$23,853 after depreciation. Income reached \$3,156,966 and expenses totaled \$3,133,113.

Income

Program income was generated from contract and service billing. This represented 56.9% of our annual income.

31.8% of income was generated from charitable donations, events and grants.

Additionally, we received two large bequests that totaled 10.9% of income.

Rental income and interest made up the remaining .5%.


Expenses

Program staff expenses and other direct program costs made up 88.7% of total expenses. This included costs for our facility and daily operation.

We spent 3.3% of our expenses on fundraising and 3.7% on management costs.

We incurred a loss on investments of \$33,124.

Depreciation made up 3.3% of total expenses.


