Healthy Families

Teaching children of all developmental and ability levels side by side for over 40 years. Ages 3-6.

Intensive Treatment Services

Psychiatric day treatment for children with severe behavioral and emotional challenges. Ages 3-6.

Relief Nursery

Preventing child abuse and neglect through respite care, home visits, and therapeutic classrooms. Ages 0-6.

Child, Teen and Family Counseling

Providing individual, group, and family therapy to ages 2-18 and their families.

Dear Friends,


Thank you for your generous gifts during this last year. Your support helps build a community in which children are safe, healthy and supported; families are connected by strong bonds, and better able to live life to their full potential.

The need for the services offered by our five programs continues as families face challenges like multi-generational mental health and addiction, the impact of mental illness on families and children, economic pressures from high housing costs, and marginalization of some families. The stress caused by these factors affects children particularly hard. As a result they can struggle in their development without additional support.

This last year we took further steps towards bringing all our Relief Nursery services to the Monroe and South Benton County Community. This will soon give local children access to toddler and preschool classrooms as well as additional parenting support to their families. Often those living in rural areas experience additional barriers like the cost of transportation and lack of local resources. Your support will help us bring these needed resources to this community.

As our work progresses, we see children and their families grow, become more resilient, and participate more fully in our community. We couldn't do this important work without you.

Books Distributed to Homes

Our home visitors provide families with free books to take home, encouraging early literacy and positive family interaction.



1,956

Classroom Meals Served

The Relief Nursery serves a nutritious lunch and snacks to children in the therapeutic classrooms.



6,732

Volunteer Hours

Volunteers help with child care, classroom activities, events, administrative work, and facilities projects.

Home visits provide parents with support in areas like parent-child bonding, childhood development, and conflict management.



89 Quilts & Cuddlers Delivered

Local nonprofit organization Quilts From Caring Hands specializes in making quilts for children at risk. They donated 89 quilts this year, which were distributed at every Welcome Baby visit for newborns in our Healthy Families program.

Did You Know...

VOCA Grant: Because we serve victims of crimes such as domestic violence, sexual assault, and child abuse, we receive funding through the Victims of Crime Act (VOCA).

Transportation: A key change to our Relief Nursery program was contracting for transportation services with Benton County Dial-A-Bus. This has increased our direct client expenses, but reduced staffing needs.

New EMDR Therapy: 68 children in therapy have experienced relief from past trauma using groundbreaking Eye Movement Desensitization and Reprocessing therapy.



Teen Parenthood: A Story of Resilience



Jessica and Cody joined the Healthy Families program in the winter of 2018. Jessica, 18 and Cody, 17 had discovered they were pregnant just 8 months previous. Being pregnant and navigating the throes of high school was emotionally and physically challenging. The stigma placed on teen parents by society and school resulted in Jessica hiding her pregnancy for the first 6 months from both her family and her school. This decision delayed the typical prenatal visits most moms-to-be receive.

Jessica and Cody's story is one of both strength and struggle—a true representation of what it means to be resilient.

After making the courageous choice to disclose the pregnancy to her family, Jessica began to receive prenatal care and was quickly referred to the Healthy Families program.

Jessica and Cody became parents to Hunter James in January 2019. From day one, the love for their child was evident. Both Jessica and Cody have continued to develop their parenting skills through weekly visits that provide hands-on parent-child activities to nurture Hunter's development and keep track of his milestones.

Soon after Hunter was born, both Cody and Jessica decided that graduating high school with their original class was important to them. Through intensive goal planning, accessing tutors and online classes, and joining the teen parenting program at College Hill High School, both Jessica and Cody met their goal in June 2019. Jessica is now enrolled to start classes in the fall at LBCC and Cody is working two jobs to help support his family.

Jessica and Cody's story is one of both strength and struggle. With continued guidance from their Healthy Families home visitor, these young parents are becoming a true representation of what it means to be resilient.

In June, 13 students graduated from our Community Preschool. They will begin kindergarten in the fall.

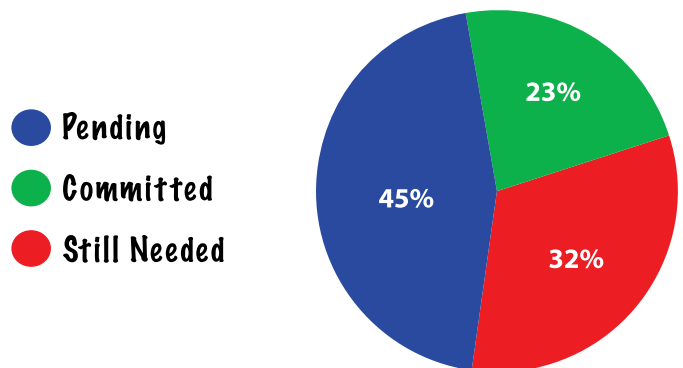
Monroe Relief Nursery



Starting in 2016, we began serving families in South Benton County through home visitation. Now, after years of planning, the Monroe Relief Nursery classroom is poised to open in Fall 2019.

This new satellite location will provide families with a variety of services, including respite care, a therapeutic preschool classroom, parenting education, and a resource closet. These services will help prevent child abuse and neglect through support, early intervention, education, and outreach.

Financial Overview

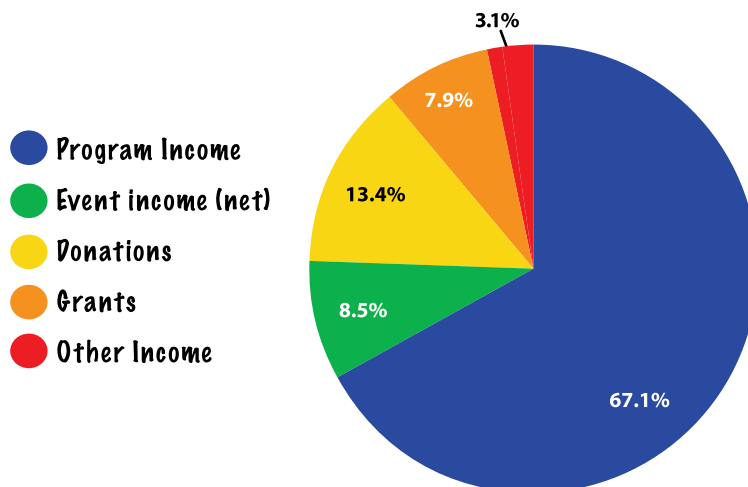
The financial year concluded with a small deficit of \$59,737 after depreciation. Income reached \$2,634,360 and expenses totaled \$2,693,733.

Income

Program income is generated from contracts and service billing. This represents 67.1% of our annual income.

29.8% of income is generated from charitable donations, events and grants. *Grant income rose to 7.9% of income during the year.*

Rental income and investment returns made up the remaining 3.1%.

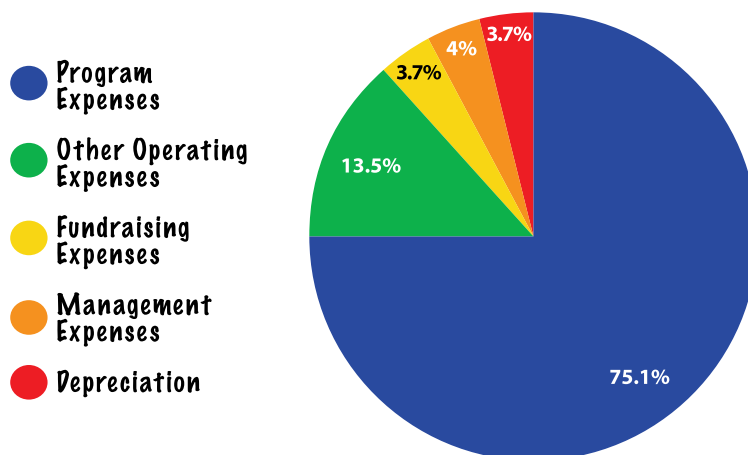


Expenses

Program staff expenses and other direct program costs make up 88.6% of total expenses. This includes costs for our facility and daily operation.

We spent 3.7% of our expenses on fundraising and 4.0% of expenses on management costs.

Depreciation makes up 3.7% of total expenses.

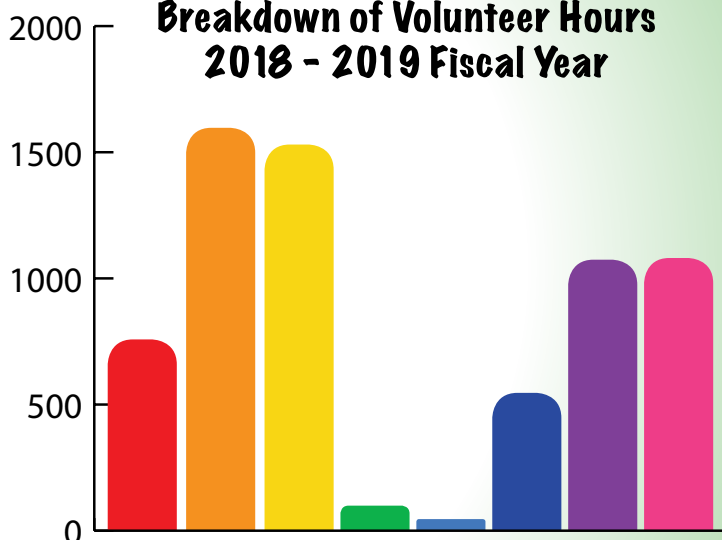
